### 1 Who we are?

## Q&A

### 1. Do you consider yourselves a Hungarian or an international law firm?

We are a fully Hungarian-owned law firm, independent of any international networks. We are, however, aware that most of today's business transactions have a global nature and contain cross-border elements. Lawyers who fail to adequately respond to these developments and who limit their focus on their domestic market, cannot successfully face the challenges of our time. This is why in the recent years we have paid special attention to developing our international professional relations and co-operations.

In 2013 we joined International Lawyers Network, a New Jersey-based association employing aggregately 5,000 lawyers worldwide. At the same time the firm also became member of Law&Numbers, a boutique network combining European tax advisory practices. As a result, in cross-border matter we can rely on foreign law firms providing the same quality and level of services as we do. Beyond this, through these alliances, we have an access to a continuously updated legal knowledge base.

It also strengthens the international perspective of our firm that our associates gained their professional experience at reputable, international law firms or tax advisory firms, where they acquired professional work ethic and high-level problemsolving skills. We provide advice in English and, occasionally, in German and French.

## 2. In what type of cases do clients approach the firm?

We do not present ourselves as having a universal scope of practice. We dare to confess that we are not proficient in each and every area of law. We provide, however, a premium service in all those areas where we are present.

We focus on tax law, corporate, commercial law, M&A transactions and real estate law. Furthermore, we regularly provide advice in the field of labour law and IP law. Areas, such as energy law, telecommunication and environmental law fall out of our firm's scope of activities.

## 3. Which areas of business are the clients of the law firm typically engaged in?

Our clients come from various sectors. It is to be noted that a given tax-related problem may equally affect а company operating in the telecommunication industry and another one manufacturing goods. Furthermore, in M&A transactions basically the same legal concepts are used, regardless of the sphere that the target company is engaged in. As a consequence, our clients come from a rather wide range of sectors, including start-ups and multinationals. We regularly advise capital funds, investments funds and investment banks. In addition, in the area of tax, the firm provides advice to international law firms, accounting firms and other advisory firms.

## 4. What makes the firm different from other participants of the legal market?

Our focus on tax law distinguishes us from other Hungarian law firms of similar size. While even the leading law firms provide tax advice only as an ancillary service only, tax advisory is one of the main areas of practice areas of our firm.

We are, further, unique in the sense that we are able to provide our services in a comprehensive manner. This means that when drafting transaction documentation, we are able to consider both the legal as well as the tax aspects of the transaction, thus preventing any possible deadlocks caused by the typically separate work of legal and tax advisors. ## 5. Which practice areas of the firm experience the most dynamic growth?

Although the firm does not generally represent clients in litigations, in the recent years we have experienced an increasing demand from our clients to assist them in tax disputes. As a response, we established a special sub-group within our tax practice focusing on tax litigation. We now represent our clients in numerous tax procedures and our success rate is very impressive.

The financial crisis has also created a significant demand for insolvency advisory and financial restructurings. In the past years we have gradually gained substantial experience in these fields as well.

## 6. What is the greatest advantage of the firm compared to the international tax advisory firms?

Members of our tax team have gained their professional experience with reputable international tax advisory firms. Consequently, the quality and professionalism of our services is on par with and, in certain aspects, exceeds that of the Big Four firms. Thanks to our legal knowledge, we can deliver such tax solutions that are in fully compliance with the applicable legal provisions.

As opposed to the standardised practice of the international tax advisory firms, we are able to work with flexible and diversified methods and tools. We

are able to build a much more personal and intimate relationship with our clients while, at the same time, offering a high level of responsibility and a maximum level of attention towards ethical considerations. Instead of solely performing tasks, we strive to provide our clients with real solutions to satisfy their real needs.

## 7. What kind of challenges does the firm face in the current business environment?

Looking back into the last decades, we can conclude that the Hungarian economy has never faced the same level of uncertainty and unpredictability as today. In this environment all strategic decisions of the firm require careful consideration.

Clearly, all market participants have been heavily affected by the economic crisis. As a consequence, cost effectiveness became a primary focus of the clients upon the selection of their legal advisor. At the same time the demand for high level advise remained a clear requirement against professional firms. This results in a natural selection among law firms: better service providers become stronger, the weaker ones disappear. Fortunately, in the recent years, our law firm was among the winners.

Apart from the economic uncertainty, the rapidly changing legal environment also created substantial challenges to legal service providers. Adaptation to the changing environment and a stronger focus on continuous in-house training also became a key feature to the success of law firms in the recent years..

### 8. What are the strategic goals of the firm?
